
浅谈区块链技术及其在海南的应用问题

摘 要

近年来，区块链技术在世界范围内不断发展，基于区块链技术的数字货币也逐渐被大众所接受，许多国家也将数字货币作为交易货币之一。但是区块链技术仍存在许多发展问题，其中包括各国法律对区块链的地位都采取不同态度，国际社会很难就区块链技术监管问题达成统一的协定，数字货币的职能也因国家的不同而难以确定具体的支付场景。中国也一直积极探索区块链技术的应用和数字货币对经济环境的影响。海南省作为中国特许自由贸易港，也专注于区块链技术的应用和数字货币的发展。

本文探究了区块链技术和海南区块链应用的发展现状和现存问题。通过规范分析法和文献分析法对比了各国对于数字货币的不同立场，总结出了目前数字货币发展的问题，并在此基础上提供了可能的解决方向。最终得出了可以将数字货币和区块链技术与海南省自贸港的发展进行有机结合，达到双赢局面的结论。

Abstract

In recent years, blockchain technology has been developing in the world, and digital currencies based on blockchain technology have gradually been accepted by the public, and many countries have also used digital currency as one of the trading currencies. However, there are still many development issues in blockchain technology, including the different attitudes of national laws to the status of blockchain, the international community is difficult to reach a unified agreement on the regulation of blockchain technology, and the function of digital currency is difficult to determine the specific payment scenario because of the differences in countries. China has also been actively exploring the application of blockchain technology and the impact of digital currencies on the economic environment. Hainan Province, as China's chartered free trade port, also focuses on the application of blockchain technology and the development of digital currency.

This paper explores the development status and existing problems of blockchain technology and Hainan blockchain application. Through the normative analysis method and the literature analysis method, we compare the different positions of each country on the digital currency, summarize the current problems of the development of digital currency, and provide a possible solution on this basis. Finally, it is concluded that digital currency and blockchain technology can be combined with the development of the Free Trade Port in Hainan Province to achieve a win-win situation.
